Thank you for your letter of November 18, 1992, requesting approval, pursuant to clause nine of H.Res. 258, of a payroll action to effect retroactive to June 1, 1992, the appointment of Ms. Peggy Adler Robohm for the period June 1-30, 1992, as an Assistant Investigator on the staff of the Task Force of the Committee on Foreign Affairs to Investigate Certain Allegations Concerning the Holding of Americans as Hostages by Iran in 1980.
